I understand and acknowledge that the following acts are considered major offenses by the school:

- b. Hazing or inflicting any physical, emotional, or mental harm or ordeal on any person, which causes injury, degradation, or disgrace, or tends to do so, including but not limited to unwarranted initiation rites for admission into any organization;
- c. Physical assault or threat against any teaching or non-teaching personnel, administration, students, or visitors within the school premises.

I fully recognize the following preventive measures and sanctions that may be imposed by the college on fraternities and other student organizations of similar nature and purpose in consonance with CHED Memorandum Order (CMO) No. 4 series of 1995 in order to deter violence:

- a. Expulsion or exclusion of any student found guilty of:
 - i. Initiating fights or violence;
 - ii. Participating in melees or violent incidents, except in self-defense;
 - iii. Possession of deadly or illegal weapons as defined by law;
 - iv. Extortion or other forms of coercion.
- b. Suspension of student officers or members involved in or aware of violent acts;
- c. Suspension or revocation of recognition for student organizations found guilty of involvement in violent or prohibited activities, with repeat offenses resulting in permanent loss of accreditation.

I commit to read, understand, and adhere to the Student Rules and Regulations as outlined in the Student Handbook or Catalogue of Information issued by the school, including the Code of Conduct applicable while inside the campus or school premises.

I understand that the school reserves the right to dismiss or take disciplinary action against any student who violates the provisions of this agreement.
